## **ORDER**

Subject: Up-gradation / Promotion of 55(Fifty Five) Junior Lecturers [6(Six) Petitioners and 49(Forty Nine) similarly placed ones] to the post of Lecturers in Government / Government Sponsored Polytechnics in compliance with the Order passed in W.P. 30843 (W) of 2014(Tarun Kumar Khanra & Ors. Vs. The State of West Bengal & Ors.) by the Hon'ble Single Bench of High Court , Calcutta read with the Order passed in FMA 2801 of 2016 (DTET Vs Tarun Kumar Khanra & Ors.) by the Hon'ble Division Bench of High Court , Calcutta.

An Order dated 31.03.2016 was passed by the Hon'ble High Court, Calcutta in W.P. 30843(W) of 2014 (Tarun Kumar Khanra & Ors. Vs. The State of West Bengal & Ors.) in favour of the Writ Petitioners, with the following directions –

".....In such circumstances, the State will take expeditious measures to recognise all junior lecturers working in a polytechnic including the petitioners as lecturers and will afford such persons with the appropriate benefits as that of the post of lecturer on and from the date of their entitlement.

W.P. 30843 (W) OF 2014 is disposed of without any order as to costs...."

Subsequently, an Order dated 20.07.2018 was passed by the Division Bench of the Hon'ble High Court of Calcutta in FMA No. 2801 of 2016 (Director, DTET, Govt. of WB VS Tarun Kumar Khanra & Ors.) by affirming the order of the Single Bench, which directed the following -

"...... The order impugned is confirmed on the question of law that all junior lecturers whether called "Demonstrators" or otherwise, who were in service as on April 8, 2009, in all

polytechnics, engineering colleges and institutions in West Bengal, whether Government, Government sponsored, non-Government and private, by virtue of the transitory provisions notified by the notification dated April 8, 2009, are entitled to be upgraded/promoted as Lecturers provided that they had the requisite minimum qualification of either a degree or diploma in the requisite subject (engineering or science as the case may be) in terms of the recruitment rules till March 2009 or if they improved their qualifications within 5 years from April 8, 2009......

..... The appeal is therefore dismissed with the above observations. There shall be no order as to costs....."

Again, an Order dated 19.04.2022 was passed by the Hon'ble Supreme Court of India in SLP (C) No. 14606-14607/2019 (Director, DTET, Govt. of WB VS Tarun Kumar Khanra & Ors.) with the following directions –

"We are not inclined to interfere with the impugned judgement passed by the High Court. Special Leave Petitions are dismissed.

Pending applications, if any, also stand disposed of."

Now, in compliance with the Order dated 31.03.2016 passed in W.P. 30843 (W) of 2014 (Tarun Kumar Khanra & Ors. Vs. The State of West Bengal & Ors.) by the Hon'ble Single Bench of High Court, Calcutta and subsequent orders passed in FMA No. 2801 of 2016 dated 20.07.2018 passed by the Hon'ble Division Bench of High Court, Calcutta as well as by the order passed in SLP (C) No. 14606-14607/2019 dated 19.04.2022 by the Hon'ble Supreme Court of India in this regard, as referred above, the Governor is, hereby, pleased to accord approval for up-gradation/promotion of 6(Six) nos. of Writ Petitioners/Junior Lecturers (Pay Band of Rs.9,000/- to Rs.40,500/- with G.P of Rs.4,400/- unrevised scale of pay as per ROPA'2009) of the Government/Government Sponsored Polytechnics to the post of Lecturers (Pay Band of Rs.15,600/- to Rs.39,100/- with A.G.P of Rs.5,400/- / Rs.6,000/- unrevised scale of pay as per ROPA'2009) of the Government/Government Sponsored Polytechnics as per the Table - A provided herewith.
